SAFETY REGULATIONS FOR THE EXHIBITOR

DUTY OF CARE

All competitors have a "Duty of Care" to avoid exposing themselves or other people to situations that could lead to injury. This "Duty of Care" extends to the prevention of damage to property.

DIRECTIONS FROM THE APOLLO BAY & OTWAY DISTRICT AGRICULTURAL SOCIETY INC.

Competitors and exhibitors must comply with any reasonable request by an Apollo Bay & Otway District Agricultural Society representative.

FIRST AID

During the Apollo Bay Show the Apollo Bay branch of Rural Ambulance Victoria will provide first aid services.

APOLLO BAY SHOW EMERGENCY FACILITIES

Fire fighting and other emergency equipment must not be removed or used for any other purpose. Missing or unserviceable equipment should be reported to the Secretary's Office immediately.

HAZARD & INCIDENT REPORTING

Exhibitors and competitors must notify the Secretary's Office immediately of any hazards detected or incidents. Hazards or incidents are any situation that has or could result in -

- the injury, illness or death of any person or animal.
- The damage, destruction or loss of property.

HOUSEKEEPING

All areas must be kept in clean and tidy order with clearly defined and access and exit routes available at all times. Build-up of combustible waste must be avoided.

WASTE DISPOSAL

All waste, including liquids, must be disposed of responsibly. Exhibitors must take all waste with them when they depart. Storm drains must not be used for the disposal of waste.

SLIPS, TRIPS & FALLS

Care must be taken to avoid trip hazards and obstacles that people may walk into. Avoid laying unprotected cables or pipes on or below 2.5 meters on paths, walkways or roads.

MEDIA COMMENTS

Media comment about matters involving APOLLO BAY & OTWAY DISTRICT AGRICULTURAL SOCIETY should be referred to the President or Secretary.

ELECTRICAL EQUIPMENT

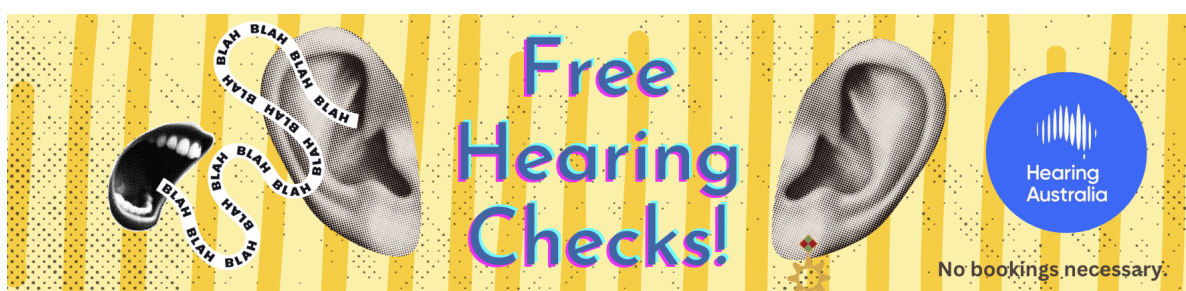
- Appliances must be in a sound working order.
- Exhibitors should supply their own 'Safety Switch' (RCD) for installation at each power outlet they use
- Extension cords must be earthed and all electrical appliances must be earthed or double insulated.
- The use of double adapters is strictly prohibited. Power boards must be fitted with current overload protection.
- Radiant electric or gas heaters are prohibited.
- Light sockets must not be used for any purpose other than lighting.
- No naked flames are permitted.
- All exhibitor electrical items, including leads, must have current safety compliance tags.

SMOKING

Smoking is not permitted inside buildings, within 10 meters of a building entrance, around combustible materials, during public performances, or while handling hazardous materials.

GENERAL REGULATIONS

1. The name and address of the exhibitor and breed of the animal must be given where required to the relevant Chief Steward on Entry Form.
2. All exhibits must be bona fide property of the exhibitors at the time of entry.
3. Reasonable care will be taken of exhibits, but no responsibility will be incurred by the Society for any loss or damage to same. It shall be a condition of entry of exhibits and of admission of persons to the Show grounds that under no circumstances can the Society be held in any way responsible for any damage or costs for any damage or injury or accident to any person or exhibit or property of any kind that may occur in the Show grounds. Every person who enters the Show grounds or competes in any event does so at his or her sole risk.
4. Stewards will be appointed to accompany the Judges to prevent interference and to give all possible information and assistance to the judges and exhibitors.
5. After examination, the judges shall sign and give their report to the Chief Steward and/or Secretary, and their decision shall be final.
6. All stock which receives prizes in the horse sections must be paraded in the ring when requested by stewards, otherwise the prizes may be forfeited.
7. The committee reserves the right of refusing, cancelling or rejecting any entry without giving reason for doing so.
8. a. Entries to the Show are accepted subject to the rules and regulations of the Society
b. The exhibitors agree to be bound by those rules and regulations.
c. The exhibitor also agrees to abide by all decisions made by the Society, by the Group with which it is affiliated or by VAS Ltd pursuant to those rules and regulations.
9. No decision so made shall be called into question by the exhibitor before any court or other body (whether or not of similar nature to a court) whatsoever.
10. Sections with fewer than three entries will be awarded a prize card but no award monies will be distributed.
11. The committee may withhold any prize where an exhibitor making an entry has made statements proved to its satisfaction to be erroneous or fraudulent; such exhibitor and his/her exhibit will be disqualified and debarred from exhibiting, riding or competing at the Society's Show at the pleasure of the committee.
12. All entries must be made subject to the rules and regulations of the Society, and are accepted only on that distinct understanding.
13. Any persons causing annoyance by loud comments on the decision of the judges, or other unseemly or insulting behavior will, after having been cautioned by a member of the Committee, a Steward, the Judge, or the Secretary, be expelled from the Show, or if an exhibitor, may have his/ her exhibit disqualified.
14. Any Chief Steward or Judge may order any animal not under proper control to be removed from the ground.
15. Every exhibitor of stock must, if requested, make a statutory declaration to the effect that the exhibit is his or her bona fide property, and that he or she has adhered to the rules as laid down by the Society. In stock, any entry not competing in the section entered will not be allowed to parade.
16. The committee reserves the right to alter Judges in any section if necessary.

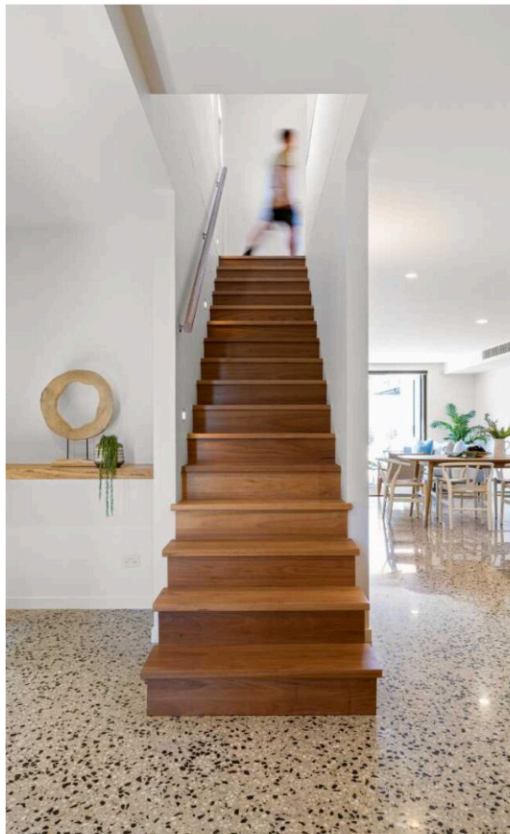
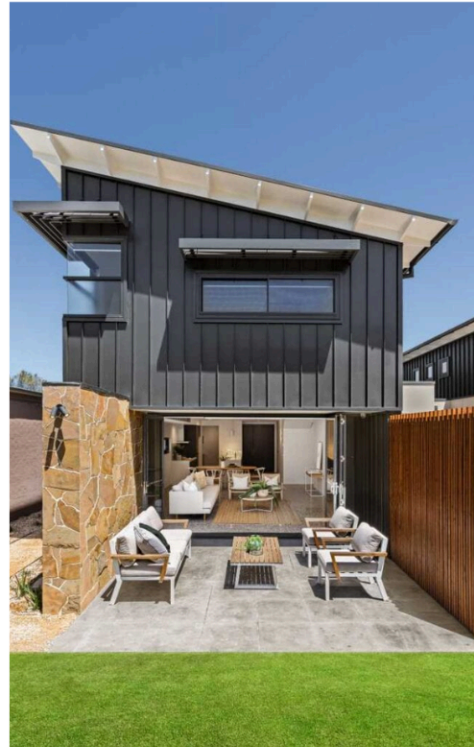

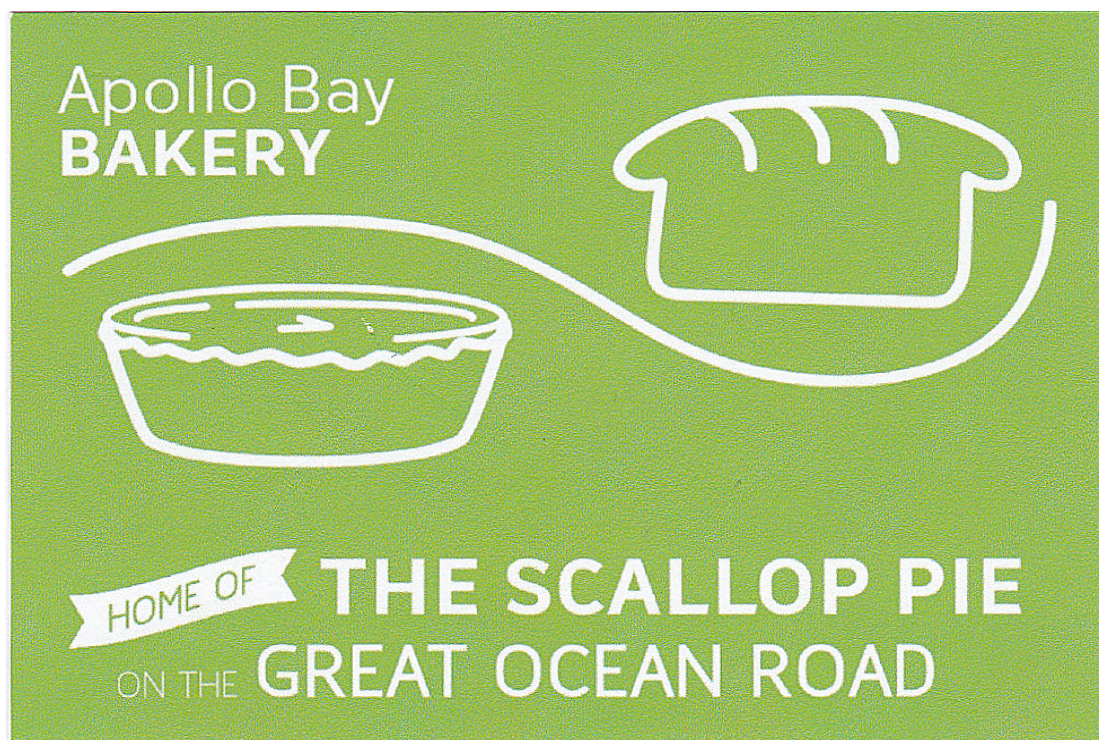

Horse and Rider Stop Over in Apollo Bay:

The Ground will be open for camping from 5PM Thursday 13 March 2025 until 5 o'clock Tuesday 18 March 2025.

Horses to be kept in designated area beyond the cypress tree for overnight or longer stays. You must supply your own yards and leave area free of rubbish. Please keep horses out of areas marked not for use.

NO FIRES ON GROUNDS – NO EXCEPTIONS

There is no horse accommodation in the Recreation Reserve. (Show grounds)

A fee of \$2.00 per person per shower when using facilities at the Recreation Reserve.

HORSE REGULATIONS

- Entries will only be received subject to rules and regulations of the Apollo Bay and Otway District Show Society and the decisions of the Horse Committee.
- In similar classes, the Chief Horse Steward has the right to make new classes in the event of sufficient entries, or to combine classes if there are insufficient entries.
- Prize money indicated for competition classes is only payable for classes in which there are four or more competitors.
- Owners entering their horses or ponies do so entirely at their own risk, and it is a condition of entry that no liability of any kind attaches itself to the Society, its officials or members in any respect whatsoever.
- Where height is stipulated E.V., SHCV or R.A.S Height Certificates must be shown upon request.
- Definitions:
 - Novice** Not having won a 1st prize competing in an Open class at an Agricultural Show.
 - Elementary** Not having won a championship at an agricultural show.
 - Intermediate** Not having won a first at a Royal Show.
 - Open** Open to all exhibitors who meet the class criteria.
 - Owner exhibitor** Horse must be prepared and exhibited by Owner as shown on registration papers, such as E.V or any Recognized Breed society or statutory declaration.
 - Veteran** Over 45 years of age.
- Random swabbing may take place.
- In competitions based on age categories proof of age must be provided on request. Proof of Age will be accepted in the form of a birth certificate, extract of entry of birth, statutory declaration by parent, baptismal certificate or school Principal certificate. Age is at the date of the Show.
- All riders under the age of 18 years must wear approved safety helmets and are not permitted to wear top boots in riding classes.
- All riders must wear riding helmets to current Australian Standards.
- In all Pony and Riding Club classes the following conditions apply: All competitors must be financial members of a recognized Club associated with the PCAV or HRCav and hold a current Member's Card. Official Uniform must be worn.
- All events to be held over such course and obstacles as the Committee may decide.
- The breeding year dates from 1 August in each year
- No Rigs allowed.

- Stallions and colts are not eligible to compete in ridden classes, except where stipulated.
- All Stallions and Colts over 2 years of age must at all time wear head-collar, bit and chain. Handlers must be over the age of 17 years. Colts less than 2 years of age must be under proper restraint at all times, and preferably wear head-collar and chain.
- All foals must be haltered in the ring.
- The term "Coloured" Horses and Ponies refers to broken-coloured animals or those registered with a recognized society.
- No lunging on the main arena.
- Warm-up of horses to be undertaken only in specified areas or at the direction of the Committee.
- All rules are at the discretion of the Committee who also consider the rules of EV, VASL, HRCav, PCAV and recognized Breed Society.

3. The dog is permitted to jump on to or over the jump.
4. A dog who has won at a Local Show/Field Day Level will qualify for the State Final. A dog can represent only ONE local Show/Field Day.
5. Each Society conducting this competition must supply to V.A.S.A. in writing immediately following the Show:
 - a) Name of the winning dog in each section.
 - b) Height jumped by winning dog in each section.
 - c) Name, address and telephone number of owner of winning dog in each Section.
6. All dogs not competing must be on a lead with a handler in the Marshalling Area behind the competition area. Competition area should be 15 metres long by 8 metres wide.
7. Only ONE dog may be loose in the competition area at any one time.
8. Every dog must compete at every height.
9. There must be a handler at the top of the jump to act as a catcher if necessary, and a handler as a catcher at the bottom. The dog's owner must supply the extra handler.
10. Each dog is allowed three attempts at each height if necessary.
11. In the event of two dogs jumping the same height, the winner shall be determined as the dog that took the least number of attempts for the winning height.
12. If the dog is not on a loose lead, the dog must be released at a minimum of three metres from the jump
13. ANY MISHANDLING OR MISUSE OF A DOG WILL INCUR IMMEDIATE DISQUALIFICATION.
14. If, in the opinion of the Stewards, a dog is unsafe to other competitors or the general public, it will be withdrawn from the Competition.
